Learned counsel appearing for the Pollution Control Board has placed on record before us a statement showing that out of 5 stone crushers which are alleged to be on the river bed; 3 Units have been granted Consent to Establish' as well as the 'Consent to Operate' and Application of other 2 Units for renewal of consent is pending.

Orders of the Tribunal

It is further stated that Krishna Stone Crushers and Golden Karamjog Stone Crushers though had been granted consent to establish but have not been granted consent to operate are operating without consent of the Board.

Having heard learned counsel appearing for the parties, we direct that Krishna Stone Crusher and Golden Karamjog Stone Crusher shall not operate henceforth till the time these stone crushers apply for consent to operate and same is granted by the Board in accordance with law.

After the Board grants its consent the Order will be placed on the file of the Tribunal and shall be subject to further directions by the Tribunal.

As far as remaining 2 stone crushers are concerned, their Application for renewal of consent is pending with the Board. Let the same be decided within two weeks from today and the copy of the Order shall be placed on the file of the Tribunal.

The Member Secretary of the Pollution Control Board shall file a personal Affidavit clearly stating if these 5 stone crushers are located on the river bed and or in around within the prohibited limit. It will also state that whether these stone crushers are within 500 mtr of any vicinity or habitation, upon taking of an inspection the Affidavit shall also show whether these stone crushers have the caustic covers and water sprinklers fixed at their premises..

The Pollution Control Board shall also examine noise, stake, ambient and air quality samples in and around these stone crushers and place an analysis report before the next date of hearing.
