M/s Shakumbari Straw Products.</li><li>2. M/s National Industries Corporation, Bilari.</li><li>3. M/s Ajudhaya Sugar mills, Bilari.</li></ol> <p>Central Ground Water Authority was also impleaded. The Learned Counsel appearing for CGWA had taken notice and waived service of notice on the same day. They were directed to take a detailed survey of ground water contamination and submit a report by today. the Learned Counsel appearing for CGWA prays for time to file the Report.</p> <p>The Learned Counsel appearing for the applicant submits that he could not serve notice on the newly added parties. The UPPCB is directed to serve notice on the industries newly added, to appear on the next date of hearing i.e. on 30.05.2016.</p> <p>Learned Counsel appearing for the CPCB submits that soil was not collected at that time of earlier Joint</p>

inspection and by order dated 30.03.2016 there was a direction to analyze the soil also and as it was collected it could not be analyzed. The CPCB and UPPCB are directed to conduct a Joint Inspection to collect the soil and thereafter analyze the soil from any relevant institute/university and submit a report by the next date of hearing.

CGWA shall submit the report as directed earlier by the next date of hearing.
