Bharat Singh, Joint Director submits that the high tide line in relation to Coastal area for the entire country has been demarcated and given to the States. He further states that the security clearance with regard to Western Coastal Areas would be received by the Ministry by 10<sup>th</sup> September, 2017. This statement is duly supported by the officer from the Survey of India and officer from the Army Headquarters.</p> <p>In light of the above, we direct that the security clearance must be submitted to Ministry of Environment, Forest and Climate Change by 10<sup>th</sup> September, 2017 and the State Governments of Goa, Maharashtra, Gujarat, Karnataka and Kerala who have already been provided with the high tide line in relation to their coastal areas must prepare their Coastal Zone Management Plan (CZMP) without any delay now and submit the same to Ministry of Environment, Forest and Climate Change for finalization.</p> <p>Let this matter be listed for further directions on 12<sup>th</sup> September, 2017 and Ministry of Environment, Forest and Climate Change will serve the Notice on all these western coastal areas States who's senior officers to remain present before the Tribunal on 12<sup>th</sup> September, 2017.</p> <p>.....,CP (Swatanter Kumar)</p> <p>.....,JM (Raghuvendra S.
