Both the Chief Secretaries of State of Haryana and Delhi are present in Court today.

The Chief Secretary of Delhi is also assisted by other officers who are also present in Court today.

Without going into the details of the Minutes recorded for the meeting held on 28th March, 2018, it is agreed by both the Chief Secretaries that they will have a meeting preferably today with the Secretary, Ministry of Water Resources, River Development and Ganga Rejuvenation (WR, RD & GR) along with their officers.

We expect the issues pending between the State of Haryana and Delhi to be resolved in the meeting with regard to the supply of water to Delhi.

The Chief Secretary of Haryana assures that there will be no reduction in the supply of Water to Delhi.
