<p>Item No. 06 March 22, 2016</p>	<p>The Status Report filed by the Sub Divisional Magistrate, Saket shows that out of Khasra No. 47 an area approximately 9 bighs is within the boundary wall erected by BSES. The Status Report submitted earlier by the same Sub Divisional Magistrate shows that as per the revenue record maintained in the office, Khasra No. 47(32-07) situated in the revenue estate of Village Asola, Gram Sabha land, is (Johad/pond) It is seen that demarcation was not done by Sub Divisional Magistrate but by the concerned Patwari. The Sub Divisional Magistrate was not present at the time of demarcation. Let demarcation be done again in the presence of Sub Divisional Magistrate and the exact extent of land in Khasra No. 47 included within the wall constructed by the BSES be ascertained let the exact classification of the land in Khasra No. 47 be ascertained and report be filed. The Sub Divisional Magistrate shall also report whether any alternation has been effected on the land in Khasra No. 47, included within the boundary wall constructed by</p>

BSES. The Representative of BSES shall be present at the time of demarcation. The Sub Divisional Magistrate shall also ascertain whether the photographs at annexures A-7 and A-8 reflect the actual position of the disputed land. The applicant is also at liberty to be present at the time of demarcation. Intimation be given to the Applicant and the BSES of the inspection in advance.
