In the matter of all independent Applications, filed by some of the Noticees, Learned counsel appearing for the non-Applicants accept Notice of the Applications. Let the Reply be filed within two weeks from today with advance copy to the Learned counsel appearing for the Applicant who may file Rejoinder thereto, if any, within two weeks thereafter.

Noticees who have not filed their respective Replies and documents as of now are granted liberty to file the same within two weeks from today with advance copies to the Learned counsel appearing in the case.

In the meanwhile, the State Government shall ensure the strict compliance of the orders of the Tribunal and no construction whatsoever should be permitted to come up in and around the Kaziranga National Park. Even the Patta holder cannot raise any construction in the eco sensitive area or in the buffer zone as Patta gives a right in the land primarily for agricultural purpose and nothing more.

The status report shall be filed by the State within two days from today. The State shall also file a comprehensive map of Kanziranga National Park with its boundaries and offending structures exiting within 5 Km. of the boundaries of the Kanziranga National Park.

Notice be issued to all the offending parties mentioned in the Annexure F of the Report.

We direct that the bailable warrants issued against

the Noticees, who are represented through the counsel and their presence is also marked in the order sheet, will not be executed against them as they ensure the Tribunal that they would be regularly appearing in the matter and comply with the directions and orders of the Tribunal. Liberty is granted to them to file their Replies with complete details.

List these matters on 14th and 15th September, 2015 at the end of the Board before this Bench only.
