However the suggestions made by the Learned counsel can hardly be considered by the Tribunal in absence of Ministry of Environment and Forests (for 'MoEF') which is a necessary party and infact was appearing prior to this day before the Tribunal.

Respondents have made various submissions in the matter.

At the cost of repetition, we have noticed that in number of cases today and even yesterday nobody appeared on behalf of MoEF. Thus, compelling the Tribunal to adjourn the cases. We are unable to appreciate this conduct on the part of the MoEF. We could have proceeded to pass some coercive Orders today, but in the interest of justice, we defer the proceedings in this case which involves serious issues of grant of EC for road construction in the Kanziranja Sanctuary and death of wildlife, due to rash and negligent driving in that area.

Except Sr. Officer who would ensure the compliance of the directions issued by the Tribunal, other Officers' presence before the Tribunal is exempted till further Orders. However they should ensure that the Learned counsel appearing for the parties get appropriate instructions prior to the next date of hearing Let copy of this Order be also sent to the Secretary of MoEF for appropriate action at his end.

Let this matter be listed on 19th November, 2013. Interim orders to continue.
