Item No. 4 25th August, 2014	<p><u>M.A.No. 418/2014</u></p> <p>Misc. Application No. 418/2014 has been filed on behalf of M/s Shakti Televnetures, Industrial Area, Mandideep praying for restoration of water and electricity connection. The MP Pollution Control Board has also submitted the information after fresh inspection has been carried out by them on 22.08.2014 in respect of the 6 industries against whom orders for disconnection of water and electricity had been issued on account of not having relevant consents.</p> <p>We have heard the Learned Counsel and the representatives of all the 6 industries against whom orders had been issued for disconnection of electricity and water as well as the Learned Counsel for the MPPCB. We have considered the submissions of the MPPCB according to which the deficiencies which had been pointed out, have been rectified by the respective 6 industries. However, it is submitted that within a week their</p>

application for renewal of the consent shall be considered and necessary orders issued.

In the light of the above and particularly based on the information which has been placed before us and agreed by the parties it is clear that each of the aforesaid 6 industries had been continuing their operations without obtaining valid consent from the MPPCB for different periods ranging from 2010 to December, 2013 when their respective consents expired.

The Learned Counsel appearing for the Industries submitted that instead of penalising them, they may be permitted to submit proposals keeping their financial limits in view, to undertake activities by way of CSR. We, in principle accept the aforesaid submission of the Learned Counsel and give them 2 weeks time to submit their proposals and the details of such CSR activities which the 6 aforesaid industries purpose to undertake.

In view of the above, it is submitted that the Electricity Board and the AKVN shall restore the water and electricity connections of the aforesaid 6 industries namely M/s Anand Industries, M/s Steel Innovation, M/s Integrated Infosys, Ms/ Shakti Televentures, M/s Tranwin Industries, M/s S.S.Bindra Flour Mill.

Accordingly, M.A. No. 418/2014 stands disposed of.

M.A.No. 419/2014

In view of the aforesaid order, the Misc. Application No. 419/2014 filed by Mr. S.S. Bindra seeking restoration of water and electricity connections also stands disposed of.

The Learned Counsel for the Municipal Board, Mandideep has filed a statement regarding the plantation that has been carried out. Shri Sachin

K. Verma, Learned Counsel submits that he would also submit the required information.
