<b>Date and Remarks</b>	<b>Orders of the Tribunal</b>
<b>Item No. 7 August 13, 2013</b>	<p>Vide our previous Order we had permitted the Applicant to inspect the entire city of Nakodara and place on record relevant information with regard to collection and disposal of Municipal Solid Waste (MSW).</p> <p>Some photographs have been brought to our notice which clearly demonstrate a dismal picture of the entire collection and disposal of MSW. In fact at most of the places the garbage particularly containing plastic and polythene are thrown on the roads near Bus stands and Hospitals and other public places. One trolley which is carrying the garbage is open which itself will cause littering of garbage through the entire route. It is completely in contrast to some photographs that had been placed on record by the Respondents earlier showing clean site but even those photographs do not show any dust bins kept where garbage had been thrown. This shows apathy and the attitude of the public Authorities and the Authorities of the Corporations towards management of MSW and public health.</p> <p>There is serious dispute before us as regards the site where MSW is being collected and disposed of.</p> <p>Compelled with these circumstances and having noticed no effective remedial measures being taken by the Corporation, we direct the Deputy Commissioner, Superintendent of Police of the area and Chief Executive Officer of the Corporation to be present before us on the next date of hearing with comprehensive and complete proposal of collection and disposal of MSW.</p>
