25-08-2014 we had constituted a Core on Committee to survey and carry out local investigation as regards the impact on environment of industrial development in Singroli area and called for its report vide order dated 25-08-2014. A comprehensive report was filed by the CPCB, whereupon CPCB was directed to place this on website-vide order dated 29-09-2015. report Reportedly, this has been done. We hope that every stakeholders particularly the interveners, have obtained the copies of this comprehensive report.

We had further directed the concerned State Governments and the respective Boards to hold a meeting of all the stakeholders inorder to propose to us the steps to be taken for controlling the air and water pollution vide order dated 29-09-2015. We are told that this meeting took place and stakeholders attended the meeting. The outcome of this meeting in form of the suggestions have come from State of Madhya Pradesh and MPPCB. Learned Counsel appearing for the UPPCB at this stage submits that UPPCB has also placed on record its suggestions following the said meeting vide Compliance Report dated 03-11-2015 filed on 30-11-2015. Only suggestions from State of U.P. following this meeting are to come before us. Learned Counsel appearing for the State of U.P. submits that such report will be filed positively on or before 27th January, 2016. We have before us the intervention application of one of the Stakeholder i.e. M. A. No. 1241 of 2015 Participation of the intervener i.e. Northern Coalfields Ltd. (NCL) in the present proceedings is warranted particularly in view of their stakes in subject matter of the present application M. A. No. 1241 of 2015 is therefore, allowed. Intervener is permitted to be joined as party Respondent. Copies of this application as well as report filed by the State of M.P., M.P.P.C.B. and U.P.P.C.B shall be furnished to the interveners. Copies of these reports shall also be furnished to other respondents.
