<p>Item No. 01 August 23, 2016 A</p>	<p>Learned counsel appearing for the State of Uttarakhand has placed before us a detailed map showing the line of middle of the river, 100 meter from the middle of the river and the proposed sites for beach camps.</p> <p>We direct State of Uttarakhand to file a personal affidavit of Additional Chief Secretary (Chairman of the Committee) in consultation with Principal Chief Conservator of Forest of State of Uttarakhand which shall state as to why a particular site like Site No. 1 is being rejected, reasons thereof duly supported with revenue records, the details as directed in relation to Site No. 9 and likewise.
