(Emergency Planning, Preparedness and Response) Rules, 1996. The distilleries which are carrying on business of Ethanol production do not require any approval from competent authorities. They are required to take approval from Petroleum and Explosive Safety Organisation (PESO).



The matter was dealt by this Tribunal inter-alia on
30.08.2017. The Tribunal gave following directions:

1. "PESO as well as State of Uttar Pradesh and all concerned States shall take appropriate action in accordance with law i.e. hazardous waste, chemical waste rules and the PESO as it is the competent to issue licenses. In authority our considered view, being licensing authority it is vested with obligations to ensure that the person/industry do not generate or produce absolute alcohol without obtaining the license prior to such production.

We direct that the five industries in the State of Uttar Pradesh detail of which as follows:
a. They shall not manufacture or produce absolute alcohol till further order.
b. Notice may also be issued to them, if they so desire, to apply vacation of this order."

Our attention has also been drawn to the minutes of the meeting conducted by the Ministry of Environment, Forest and Climate Change in pursuance of directions of this Tribunal with a view to consider as to whether industries producing ethyl alcohol require any license and who is the competent authority for issuing the license. In the meeting, representative of the Ministry of Petroleum and Natural Gas (MoP&NG), Uttar Pradesh Excise Department, Uttarakhand Excise Department, Bharat Petroleum Corporation Limited (BPCL) and Central Pollution Control Board participated. The issues formulated were as follows:



(a)	"The Central Government in the Ministry
	of Environment, Forest and Climate
	Change and the Ministry of Petroleum
	and natural Gas has no role so far as
	issuing of licenses in respect of ethyl
	alcohol manufacturing is concerned;

- (b) The Excise Department is the concerned agency in the State Government/Union Territories for issuing licenses under Excise Act for manufacturing ethyl alcohol;
- (c) Approvals/permission/NOCs from multiple agencies are required by the Excise Department as pre-requisite for issuing license;
- (d) Mandatory licenses under Explosives Act are required to be obtained from PESO;
- (e) The State authorities, in particular, the Chief Inspector of Factories, are required to implement the provisions of MSIHC Rules, 1989 and violations if any, to be dealt in accordance with law."

4. We are of the view that as noted in the order of this Tribunal dated 30.08.2017, PESO is the competent authority to issue licenses and to ensure that no industry producing absolute Alcohol functions without such license. Accordingly, directions in our order dated 30.08.2017 absolute. Such industries are required to comply with the Manufacture, Storage and Import of Hazardous Chemical Rules, 1989 specially with regard to preparation of on-site emergency plan as well as off-site emergency plan as required under Rules 13 and 14 of the said Rules. It is clarified that the direction in order dated 30.08.2017 prohibiting manufacture of absolute Alcohol is applicable only till an appropriate license is obtained.

5. We are hopeful that the concerned statutory authority will take appropriate action in respect any

	industry working without a license, including the
