Date and Remarks	Orders of the Tribunal
Order No. 1	We have heard the Learned Sr. Counsel for the Applicant. The
September 18,	issue involved in this case is about the allegtion of non-forestry
2013	activities being done in the forest area which is Braj area to the extent
19-11	of 50 <mark>00 Acres of land in the</mark> forest area towards Mathura, Uttar
and the	Pradesh , Haryana and Rajasthan. The Trust has taken up the work
	of afforestation in Vrindavan and Mathura in the forest area stated to
	be comprised of 5000 Acres as Braj area. The allegation as submitted
5	by the Learned Sr. Counsel is that by a Memorandum of
S 1 2	Understanding, agreed, the Applicant trust has been agreed to be
	empowered to involve in the afforestation activities in the area funded
	by some of the entrepreneurs. In spite of the same, to which
	Government is the party, allegation is that the 3 <sup>rd</sup> Parties are
	unauthorisedly involving in concretization work in the forest area.
	Thus, in our view it is a case of serious concern since it is the
	duty of the Government especially Respondent No. 3 and
	Respondent No. 4 to see that the forest area in the said place is
	maintained properly. When an organization like the Applicant has
	come forward to help the Government, which has been agreed upon,
	it is not known as to how any unauthorised 3rd Parties can be
	permitted to do some activity in the forest area.

In such view of the matter, the above application is admitted. There shall be an interim order of *status-quo* to be maintained by all the parties which exist as on date. It is made clear that no further construction shall be put up in the Braj area. The Chief Secretary of Uttar Pradesh, Rajasthan and Haryana are directed to ensure that no new projects or industrial activities or construction are permitted or allowed in the Braj area till the next date of hearing.

Since we are of the view that the aforesaid Chief Secretary, Government of Rajasthan and Chief Secretary, Government of Haryana are necessary parties, they are added as Respondent No. 5 and Respondent No. 6 respectively. Registry to carry out necessary amendments. Issue notices. Dasti and private notice is also permitted.
