None have filed their replies.</p> <p>Today, it is pointed out that the non-forest activity is gathering pace and the wall constructed by the Forest Department has been breached. M.A. No. 589/2015 has therefore been moved.</p> <p>Issue Notice to the respondents in the M.A. No. 589/2015.</p> <p>It appears that the authorities are distancing themselves from the grievance of the citizens.</p> <p>As nobody is present on behalf of Respondents despite service of notice, we issue bailable warrant in the sum of Rs. 10,000/- to the satisfaction of the arresting Officer against the Secretary, Department of Revenue & Secretary, Environment & Forest of the Respondent No. 1 – NCT Delhi for securing their presence in exercise of our powers and in terms of the</p>

provision of Section 19 (4) (a) of the National Green Tribunal Act, 2010 read with Order XVI Rule 10(3) and Section 151 of Code of Civil Procedure, 1908.

Bailable warrant returnable on 8th June, 2015.
