Item No. 10 to 14 March 2014 26,	<p>We have perused the Report of the Committee which has been filed before the Tribunal on 14th January, 2014. In the Report short term and long term measures have been suggested. Let the State of Punjab file an Affidavit stating that as to what steps have been taken in furtherance to this Report till today as more than two months are over.</p> <p>We direct the Commissioner of Municipal Corporation of Amritsar and Commissioner of Municipal Corporation of Ludhiana to be present before the Tribunal on the next date of hearing and inform the Tribunal as to what steps have actually been taken on the ground level and the money that has been spent and its effect on the underground water so far as on reduction in contamination of underground water.</p> <p>The learned Amicus Curiae also submits that in relation to Hoshiyarpur the underground water has been seriously contaminated.
