Right from 2006 till 20th August, 2014 no inspection was conducted, though consent was granted to the hotel. Furthermore, when this officer went for inspection, he noticed nothing which would have been visible to the naked eye and prepared a report which is patently false. According to him, there were six rooms for which he had granted consent, while it is admitted that by that time the hotelier has also carried out unauthorized construction. When noticing the intake capacity and the discharge in his report, he observed that there is no trade effluent discharged by the hotel while there are kitchen, rooms and residential blocks. Further he not even bothered to check up the septic tank which was for six rooms and whether it was sufficient to meet the demand of entire structure including unauthorized structure has been raised on the site. How the sewage is emptied, where the sewage is taken. There is no observation with regards to municipal solid waste. This appears that this report is primarily prepared for convenience of the hotel.
