Item Nos. 01 to 03 July 21, 2016 Meghalaya has filed a Status Report on Record. According to the Status Report there is 30,12,309 metric ton of coal lying in open for which the royalty has not been obtained. In view of what we have discussed in the various orders this is the illegally extracted coal and therefore nobody is interested in paying the royalty and transporting the coal in accordance with the Policy of the State and orders of the Tribunal.

The Learned Counsel appearing for the State of Meghalaya is directed to file an affidavit placing the complete methodology on record as to how they propose to deal with the disposal of the coal vested in the State.

Such directions would be needed at the earliest in order to ensure that there is no pollution caused by the coal lying in the open. Let the affidavit be filed within 2 weeks from today.

Learned Counsel appearing for the Ministry of Environment, Forests and Climate Change submits that they have appointed NEERI as an expert and the NEERI has submitted its report. Now, they have to take a final view on the entire mining policy. As far as the mining plan is concerned this had been sent to the Ministry of Coal which in turn has called upon the State of Meghalaya to clarify certain issues as the plan suffers certain deficiencies. Be that as it may, we direct Ministry of Environment Forests and Climate Change, Ministry of Coal and the State of Meghalaya to hold a meeting presided over by the concerned officer of the Ministry of Environment, Forest and Climate Change to finalize the mining plan and mining policy including the scheme for

the restoration of the environment and ecology. should be done within a period of 2 weeks from today. And the report shall be placed before the Tribunal. We make it clear that we would not grant any further time as this matter has been pending for submission of the requisite report from the Ministry for a considerable time now. The entire mining activity in the State has been on a standstill and causing serious environmental degradation and economic disadvantage to the people and the State both. M.A. 655 of 2016 has been filed by the applicant for a direction to be heard by the Ministry of Environment Forests and Climate Change before it declares the plan. We do not consider it necessary to pass any order in this regard. It is for the Ministry if it wishes to hear the applicant it may do so. We grant liberty to the applicant to submit his suggestion within 1 week from today. List this matter for hearing on 30th August, 2016. (Swatanter Kumar)
