The Learned Counsels for the parties submitted that a meeting with the concerned officers of the department as well as Members of the Monitoring Committee shall be convened within a week to apprise the Members of the Monitoring Committee regarding specific works which have been sanctioned and which are to be undertaken in respect of all the lakes in Bhopal, as per the programme and an affidavit submitted before this Tribunal for which an amount of Rs. 15 crore has been sanctioned this year. It is open for the parties as well as the Members of the Committee as per their field of interest and expertise to constitute sub-committees with respect to monitoring and giving suggestions on specific works being undertaken as a part of implementation of different projects on the conservation of lakes and the time schedule is observed. Care may be taken that there is no overlapping of monitoring as another Monitoring Committee is already monitoring the progress of the removal of solid waste from the Shahpura Lake.

It has been brought to our notice that in the today's publication of a newspaper published from Bhopal, there is a news item regarding constructions within the 50 mtrs. of the no construction zone from the High Flood Level (HFL) of the lake and some orders in this regard have reportedly been issued by the Collector, Bhopal. Shri Sachin K. Verma, Learned Counsel is directed to place on record the orders issued by the Collector in this regard.

We also noted that it has been reported that untreated Bio Medical Waste from certain hospitals / pathological laboratories in Bhopal city is being allowed to go into the lakes and also being mixed with Municipal Solid Waste and disposed of as such.. Shri G.S. Saluja, Executive Engineer, Bhopal Municipal Corporation is present.
