<b>Item No. 8 July 3, 2014</b>	<p>Learned counsel appearing for Respondents state that the State of Jammu Kashmir is willing to carry out the Report filed before the Tribunal by the CPCB. However, he states that funds though have been sanctioned by the Central Government, they have not been disbursed to the State of Jammu and Kashmir to enable them to take steps in furtherance thereto.</p> <p>On the oral request of the Learned counsel appearing for the parties Union of India is directed to be impleaded as Respondent No. 6.</p> <p>Learned counsel appearing for MoEF accepts Notice on behalf of Union of India and waives service. We direct him to take instruction from other concerned Ministry i.e. Ministry of Urban Development, Govt. of India. He shall clearly take instructions as to when the amounts sanction can be disbursed to the State of Jammu and Kashmir and the purpose for which such sanctioned has been made.</p> <p>In the meanwhile, the State of Jammu and Kashmir shall also file an Affidavit stating as to what are the projects covered by the stated sanctioned amount of 91 crores and the details thereof.
