aforesaid averments of the applicant with regard to the damage being caused to their residential houses.

Shri Shivendu Joshi, Learned Counsel submits that despite the aforesaid letters and the reminder the Dy. Controller of Mines, IBM, Jabalpur has failed to respond and they have not received any reply to their request.

The Registrar, National Green Tribunal, Central Zone, Bhopal is directed to issue notice to the Dy. Controller of Mines, IBM, Kamla Nehru Nagar, Jabalpur-11 asking him to appear before the Tribunal in person on the next date of hearing with the aforesaid information regarding –

- (1) Whether any house and dwelling units in an around the mining lease area of the respondent no. 5 have been adversely affected as a result of the mining operations and more particularly whether the blasting was being carried therein by the respondent no. 5.
- (2) The distance between the mining site and the dwelling unit and the villages located from the site where mining operations are being carried out and whether the same are more than 100 mtrs. as permitted in the permission order dated 09.09.2004 granted by Director, Mines Safety, Jabalpur region.

The Respondent no. 5 shall also explain under what circumstances and on the basis of what authority the mining operations are conducted by the respondent no. 5 within the restricted area of 100 mtrs. which has been fixed in the permission order dtd. 09.09.2004 filed as Annexure R-13 by the respondent no. 5.

Let the matter be listed on 20.11.2013.
