<p>Item No. 01 to 03            April 10, 2017            ss</p>	<p>The Interim reports by the committee constituted under the orders of the Tribunal have been filed.</p> <p>From the report, it is evident that the large number of Hospitals, Hotels, Bus Stands, Railway Stations, Government Colleges, other Government entities and other public buildings are found to be defaulting. The reports are definite in their expression that the corporate sector entities have not only failed to discharge their obligations under the laws of environment, but have even failed to perform their corporate social responsibility. These large government institutions and corporate sectors are expected to contribute towards betterment of the society and ensure that the municipal solid waste particularly is handled, transported and disposed of in accordance with</p>

For years they have persisted with their defaults causing tremendous environmental pollution and adverse impacts on the public health.</p> <p>In the reports submitted by the Committee, it has specifically pointed out the deficiencies, shortcomings and the defaults committed by both the Government and Corporate sectors. The corporate sectors in particular are expected to contribute towards betterment of the society and ensure that the surrounding areas to their place of business are also kept clean in the interest of environment and public health and particularly in relation to municipal solid waste which is a menace as far as the NCT, Delhi is concerned. It has been noticed in the main judgment itself the generation of municipal solid waste is 14100 MT and these major corporate sectors and important public authorities are major contributors of such waste. Therefore, they must discharge their statutory public law and duties for protecting the environment. On the basis of the report we issue Notice to show cause as to why the environmental compensation not exceeding Rs. 50 Lakh be not imposed on these defaulters and why the concerned Board be also not directed to launch prosecution under the Environmental Protection Act, 1986; Solid Waste Management Rule, 2016 and other laws in force.</p> <p>Notice will be issued to the followings :-</p> <p><b>Hospitals :-</b></p> <ol style="list-style-type: none"> <li>1.
