

were only permitted to function and operate.

The Learned Counsel appearing for the parties have commonly conceded that this Application can be disposed of in the following terms:

1. The State of UP, UPPCB, Nagar Palika & CorporationS of all these three districts and all other public authorities concerned shall fully ensure that no illegal and unauthorized slaughter houses are permitted to operate.

The slaughter houses which do not have consent from the UPPCB and/or environmental clearance from SEIAA wherever required and do not have any permission from the local authorities would not be permitted to operate either in the open or in the shops in any area.

2. M/s Rayban Foods Pvt. Ltd., Al Nafees Frozen Food, Exports Pvt. Ltd. And Al Nasir Exports Pvt. Ltd. agreed that they would help small meat shop owners as a part of their corporate social responsibility and slaughter a very limited number of animals only for sale of meat in the local areas.

3. The UPPCB shall constitute a Committee and inform the same. The small shop owners are at liberty to approach this Committee which will issue them certificate on quarterly basis permitting them to have a very limited number of animals slaughtered for sale of meat in the local areas.

4. The UPPCB shall permit these three slaughter houses to slaughter these limited number of animals in addition to capacity for which they have been permitted to operate. 5. The Central Ground Water Authority shall take due care and ensure that there is no illegal extraction of ground water by any of the slaughter houses that are permitted to run in accordance with law.

The Applicant is permitted to raise the issue in relation to pollution of river Kali in the main Ganga matter. Thus Original Application No. 339 of 2013 stands disposed of without any Order as to cost.

M.A. NO. 1062 of 2013 and M.A. No. 222 of 2015

These Applications do not survive for consideration as the main Application itself stands disposed of. There shall be no Order as to cost.

Thus, M.A. NO. 1062 of 2013 and M.A. No. 222 of 2015 stand disposed of.
