The applicant has filed photographs showing huge waste being dumped and even animals are eating plastics and other municipals solid waste. These photographs be taken on record.</p> <p>In the light of the above we direct issuance of show cause notice to all the three officers i.e. Secretary, Ghaziabad Development Authority, District Magistrate, Ghaziabad and Additional Municipal Commissioner, Ghaziabad to show cause as to why we should not direct that punitive action be taken and impose cost on them</p>

which would be personally recoverable. Furthermore, we also direct them to show cause as to why environmental compensation in terms of Section 15 and 17 of the NGT, Act, be not imposed upon all these authorities.

The Learned Counsel appearing for the respective authorities accept Notice. Let the reply to show cause be filed within two weeks from today.
