The Learned Counsel appearing for the UPPCB submits that all the above industries have been inspected by the Joint Inspection Team. Their Reports have been found favourable to the extent that they are complying and non-polluting industries.

However, in relation to Aslam Tannery, it is stated that PH exceeds the prescribed parameters. We direct this industry to take corrective measures forthwith and, before it can operate, to bring the PH within the prescribed limit. After having taken the measures, it will file an undertaking before the Board that it has ensured adherence to the PH standard.

All other industries being compliant are permitted to operate and carry on their business activities in accordance with law.

We make it clear that they will be subjected to inspection by Joint Inspection Team on regular intervals. The inspections would be surprise inspection. All the industries aforeindicated shall install the electromagnetic flow meters as indicated in the inspection reports within four weeks from today and shall take permission from the Ground Water Authority for extraction of ground water. In the event these directions are not complied with, within four weeks from today, the Pollution Control Board shall direct closure of these industries without notice.

Thus, Original Application No. 106 of 2015, Original Application No.107 of 2015, Original Application No.109 of

2015, Original Application No. 110 of 2015, Original Application No.111 of 2015, Original Application No. 112 of 2015 and Original Application No. 113 of 2015 are accordingly disposed of.

M.A. No. 298 of 2015, M.A. No. 314 of 2015, M.A. No. 305 of 2015, M.A. No. 303 of 2015, M.A. No. 301 of 2015, M.A. No. 307 of 2015 & M.A. No. 302 of 2015

These Applications do not survive for consideration as the main matters themselves stand disposed of.
