only guiding factor. According to the Project Proponent he had agreed to supply the electricity on sharing basis, between the Corporation as well as the power generating plant. According to the Project Proponent it is 3% which of course is not agreeable to the corporation. In the circumstance afore-stated, we direct Delhi Electricity Regulatory Commission to determine the rate at which power is to be purchased by the electricity company, Delhi as well as make an observation in regard to the sharing of the revenue. We direct the Corporation as well as the Project Proponent to file petition before the Regulatory Commission within one week from today and the same would be dealt with and disposed of by the Commission within one week thereafter.

List this matter for hearing on 04th May, 2016.

The commission would act in furtherance to the directions issued by the Tribunal.

The Shriram Institute will join the joint inspection team. These directions are necessitated for the reason that the Municipal solid waste is a matter of serious concer particularly keeping in view that Delhi is generating nearly 8,000 MT Municipal Solid Waste every day and the only plant in operation is at Sukhdev Vihar and the three other plants which are practically ready for operationalisation, are not permitted to operate on one pretext or other which relates to inter-departmental clearance on fixation of tariff. It would not be appropriate for the Tribunal to get into the rate as for that purpose Regulatory Authority exists and the parties are ready to approach the said authorities. If these plants do not become operate and are not kept under the strict vigilance

standard, environmental there are bound on environmental hazard as there is hardly any land available for Municipal Solid Waste dumping and sites are already over-filled and more often dust and fire generating dangerous gases which are bound to affect human life.
